Taking South Gujarat's Industrial Concerns to the State's Decision Table



Under the leadership of Chamber Vice President Ashok Jirawala, the Chamber submitted representations to the Hon'ble Chief Minister and Finance Minister regarding the simplification of the GIDC Transfer Policy and the release of pending ITC refunds for the imitation jari sector, blocked since 2023.

The Southern Gujarat Chamber of Commerce and Industry's Vice President, Ashok Jirawala, along with Hon. Treasurer CA Mitish Modi and Deputy Secretary Paulik Desai led a delegation on Monday, September 1, 2025, to Gandhinagar. The delegation made detailed representations to Hon'ble Chief Minister Bhupendra Patel and Finance Minister Kanubhai Desai on key issues concerning industries

across South Gujarat.

Chamber President Nikhil Madrasai and Vice President Ashok Jirawala stated that the Chamber specifically urged the government to announce a financial relief package to offset the potential losses faced by industries due to the recent tariff measures imposed by the United States. The Chamber also requested an extension of VAT refund benefits

under the 2012 Textile Policy for an additional two years, and providing a subsidy of Rs. 2 per unit on electricity tariffs for the textile sector.

Immediate appointment of a Master Developer for the PM Mitra Park and inclusion of the Chamber's President in its SPV Board were requested. Representations were also made to grant industrial status to automobile sales and service units currently operating in GIDC. Furthermore, requests were made to abolish vehicle tax in municipal areas, provide electricity rates for mp farming at par with agricultural rates, and approve offline applications

received under Gujarat's 2019 Textile Policy.

The Chamber of Commerce delegation informed the ministers that quick resolutions to the above issues would encourage South Gujarat's industries and provide new momentum to the region's industrial development. The representations made by the Chamber received a very positive response from Gujarat's Chief Minister and Finance Minister. The ministers listened to the Chamber's representations very patiently and assured that various issues of the industries would be resolved at the earliest.

An Honour for the Chamber: President Appointed to the Ministry of Textiles' key Committee on Fiscal and Credit Interventions

The committee will provide suggestions for resolving difficulties in banking finance and credit for the textile, apparel, and handicraft sectors, as well as other various recommendations

The Government of India's Ministry of Textiles has appointed the Chairman of the Confederation of Indian Textile Industry (CITI) as the Chairman of the Committee on Fiscal, Banking and Credit Interventions for the Textile, Apparel and Handicrafts Sector. Along with this, the President of The Southern Gujarat Chamber of Commerce and Industry, Nikhil Madrasi, or a representative appointed by him, will be appointed as a member of the committee.

Regarding the main objectives of the above committee of the Government of India's Ministry

of Textiles, suggestions for resolving difficulties in banking finance and credit for the textile, apparel, and handicraft sectors will be made in this committee. Additionally, suggestions for GST rate rationalization, tariffs, ensuring timely, affordable, and required credit for SMEs in working trade finance will be given.

A model study from around the world for export finance will be conducted, and suggestions on which model can be adopted for our country will be made by the committee members. Suggestions on how to achieve the target of \$100 billion in textile exports by the year 2030 will also be provided in the committee.

The meetings of the above committee will be held once every 15 days, with a provision to submit a annual report within four weeks. In this committee, along with the President of The Southern Gujarat Chamber of Commerce and Industry, representatives from the Confederation of Indian Industry (CII), AEPC, TEXPROCIL, CEPC, and PDXECIL will join as members.

Empowering Research Excellence: SGCCI Golden Jubilee Memorial Trust of the chamber Extends ₹ 3 Lakh Scholarships to each Ph.D. Student



The Southern Gujarat Chamber of Commerce and Industry's SGCCI Golden Jubilee Memorial Trust has provided scholarships of Rs. three lakh each to two Ph.D. students to encourage talented students excelling in education and research. In the first phase, both students were presented with cheques of Rs. one lakh each.

Chamber of Commerce President Nikhil Madrasl stated that the SGCCI Golden Jubilee Memorial Trust has awarded scholarships of Rs. one lakh each to Bhavyesh N. Desai (SVNIT) and Aniket H. Sawant (Uka Tarsadia University) who are pursuing

Ph.D. This scholarship will be valid for one year. If the students' academic performance and research work are satisfactory, they will continue to receive Rs. one lakh each for the next two years. In this way, each student will receive a total financial assistance of Rs. 3 lakh over three years. The main objective of the Trust is to provide opportunities to deserving students and advance the new generation in the research field.

Renewed Demand: Chamber Insists on Global Precious Cargo Operations at Surat Airport



Under the leadership of The Southern Gujarat Chamber of Commerce and Industry President Nikhil Madras, SGCCI submitted a detailed proposal on July 19, 2025, to Airport Authority of India (AAI), AAICLAS CEO Ajay Bhardwaj, and Surat Airport Director A N Sharma to start International Precious Cargo Operations (Import-Export) from Surat International Airport.

Prior to that, on February 7, 2025, under the leadership of the immediate past President of the chamber Vijay Mewawala and office bearers, the Chamber's Aviation and Airport Committee Chairman Limesh Shah invited the Air India Cargo team including Shekhar Mohanty, Sanjeev Sharma, and Joshua Fernandez to Surat. The meeting was attended by representatives from the Chamber of

The Chamber highlighted to the Airport Authority the potential for annual diamond and jewelry imports and exports worth USD 10-12 billion

Commerce, Surat Diamond Bourse, SDB Custom House, as well as Surat Customs officer Anunay Bhati (Hazira Office) and the Airport Customs team.

In the above meeting, discussions were held on the urgent need for direct International cargo movement from Surat, the necessity of a strong room for precious goods, fast and cost-effective logistics for exports, and making Surat India's future Precious Cargo Hub.

Meanwhile, on September 3, 2025, the proposal was further strengthened with robust data by the Chamber's Aviation and Airport Committee Chairman Litesh Shah and the Chamber's Group Chairman and GJEPC (Gem & Jewellery Export

Promotion Council) Gujarat Regional Chairman Jayanti Savaliya. The potential for annual imports-exports of diamonds and jewelry worth approximately 10-12 billion US dollars was presented to the Airport Authority. Along with this, the immediate need to establish a dedicated strong room facility at the Passenger Terminal Building was also highlighted.

In the initial phase of this proposal, the guidance of former AAICLAS CEO Keku Guzdar also proved important. After getting approval from the authorities, the implementation of this proposal will be a game-changer for Surat's exporters and will give new heights to Surat's global connectivity.

Delegation Meets Union Minister C.R. Patil, Pushes for 5% GST Rate Across MMF Textile Value Chain



C.R. Patil assured to convey the Chamber's representation to Union Finance Minister Smt. Nirmalaben Sitharaman and Union Chemicals and Fertilizers Minister J.P. Nadda

Under the leadership of The Southern Gujarat Chamber of Commerce and Industry's Vice President Ashok Jirawala, a delegation including former Chamber President Ashish Gujarati, member of the managing committee Suresh Patel, Deputy Secretary Paulik Desai, and leaders of the Nylon Spinners Association met India's Union Minister of Jal Shakti C.R. Patil on September 6, 2025, in Surat.

The Chamber delegation represented with a request to bring the entire man-made fiber textile value chain, from various chemicals like para-xylene, caprolactam, MEG, PTA to textiles, under a uniform 5% GST rate.

Nikhil Madrasl, President, Chamber of Commerce, said that a representation made by the Chamber's delegation stated that the inverted duty structure at the yarn manufacturing stage has become more severe with the rate on MMF yarn being reduced to 5 per cent from 12 per cent at present, which will lead to a huge input credit constraint. Because of this

inversion, MMF spinners will not be able to use the input credit on capital goods during their projects, as the sector is expecting an investment of up to Rs 24,000 crore in the next 3 to 4 years. A major impediment arising from this input credit issue on capital goods will be the loss of competitiveness, which will ultimately increase the cost burden on subsequent components of the value chain.

The delegation of the Chamber requested the Hon'ble Union Minister of Jal Shakti, C.R. Patil to convey this representation from the Chamber to the Hon'ble Finance Minister, Smt. Nirmala Sitharaman as well as the Union Minister of Chemicals and Fertilizers, J.P. Nadda.

Mr. Ashok Jirawala, Vice President of the Chamber said that Mr. C. R. Patil listened to the representation made by the Chamber very calmly and assured to convey the representation of the Chamber to the departments concerned as well as to the Ministers.

Kidney Care Session Held: Raising Awareness on Renal Health

President of the Chamber of Commerce, Nikhil Madrasl, stated that the main objective of this session was to create awareness among people about proper kidney care and a healthy lifestyle. Such awareness sessions help people understand the importance of adopting healthy habits and encourage the community to stay more conscious and committed towards better health.

Dr Siddharth H. Jain stated that in today's fast-

paced world, people often fail to devote enough time to their health. Taking care of vital organs—especially the kidneys—is extremely important, as kidneys play a crucial role in maintaining the body's water balance. Therefore, regular check-ups are essential for kidney health. He further emphasized that drinking adequate water is key to ensuring the long life of the kidneys. Consuming at least 2-3 liters of water daily helps keep the kidneys clean and functioning properly.

He further added that regular control of blood pressure and sugar levels is essential, as these conditions can damage the kidneys. One should avoid overusing medications and take them only as prescribed by a doctor. It is advisable to consume foods that are low in sugar and less oily. Regular exercise and a proper diet are also very important. He emphasized that reducing stress in daily

The Southern Gujarat Chamber of Commerce & Industry, the Gujarat State Non-Resident Gujarati Foundation, and the NRG Centre functioning at the Chamber of Commerce, Surat-jointly organised an NRI Marriage Awareness Seminar with support from Vanita Vishram University, on Tuesday, 9th September 2025 at 10:00 a.m. at Vanita Vishram University, Surat. In this seminar, Supreme Court advocate Preeti Joshi provided detailed guidance to young women wishing to marry men settled abroad, explaining the important precautions they should take.

Vijay Mevawala, immediate past president of the Chamber of Commerce, stated that the institution of marriage is deeply rooted in Indian culture. In today's digital era, relationships develop rapidly. When an acquaintance grows and matures into a marriage proposal, several precautions become essential. These precautions become even more crucial when the marriage involves a person settled abroad,

as one wrong decision can potentially ruin a daughter's entire life.

The keynote speaker, Supreme Court advocate Preeti Joshi, stated that the number of people migrating abroad from India is increasing day by day, and consequently, problems arising out of such marriages are also on the rise. This often leads to complex legal issues.

In cases of marriages involving Non-Resident Indians, not only Indian laws but also the private and international laws of the respective foreign country apply – many of which are far more complex. Therefore, such marriages carry higher risks.

Women often face several challenges such as language barriers, lack of awareness about local police procedures and legal systems, difficulty in accessing immediate financial assistance, and the absence of a safe place to seek shelter during emergencies.

Therefore, young women should consider the language, food habits, culture, lifestyle, and family environment of the country they plan to marry into. They must also obtain accurate and verified information about the person they intend to marry. She advised young women to take all necessary precautions before entering into a marriage abroad.

She further stated that one should never place blind trust in any bureau, agent, broker, or mediator for marriage arrangements. Under no circumstances should anyone agree to prepare fake documents. One should not be misled by promises such as obtaining a green card through marriage, nor should one agree to proposals that require traveling to another country solely for the wedding. It is essential to verify the marital status of the person living abroad—whether he is unmarried, divorced, widowed, or legally separated. In addition, one must thoroughly check matters such as immigration status, type of visa, eligibility to reside abroad as husband and wife, financial status, property ownership, residential address, and the family background of the prospective groom.

Chamber Leads National Online Meet on GST Rates with Major MMF Textile Associations

Industrialists expressed concern that since the GST rate of 18% on yarn raw material remains unchanged, a large amount of ITC credit will remain accumulated with the government.

Under the leadership of The Southern Gujarat Chamber of Commerce & Industry, an online meeting regarding GST rates was held on Tuesday, 9th September 2025, with major MMF textile associations from across India. Representatives from the Confederation of Indian Textile Industry, SIMA (Southern India Mills Association), MATEXIL (SRTEPC), Nylon Spinners Association, the Textile Association of New Delhi, Association of Synthetic Fibre Industry, Polyester Textile Apparel Industry Association, PDEXCIL, and PTA User Associations participated in the meeting.

Representatives of all the above associations expressed concern that, following the recent 56th GST Council meeting, the decision to retain the 18% GST rate on raw material for yarn has brought all synthetic yarn spinners across India under inverted duty. As a result, they fear that a very large amount of ITC credit will remain accumulated with the government.

Most spinners were planning expansion, but with such a large amount of Input Tax Credit remaining blocked with the government, the tax paid on machinery will never be recovered in their lifetime. As a result, India's MMF textile production will not remain competitive at the global level, causing losses to all spinners in the country. According to calculations, approximately Rs. 9 per kilogram of GST credit will remain accumulated.

During the meeting, all associations unanimously stated that the recent changes in GST rates by the Central Government have removed inverted duty at the fabric level, but have created significant inverted duty at the yarn level. Therefore, it is necessary to reduce the GST rate on the primary raw materials of the textile sector—Paraxylyene, Caprolactam, MEG, PTA, as well as Nylon and Polyester chips—from 18% to 5%. There should be no inverted duty anywhere within the entire MMF textile value chain. Only when inverted duty is eliminated across the full value chain will India's textile industry become globally competitive.

To achieve the target of USD 350 billion in textile exports from India by the year 2030, the polyester yarn sector alone will require an investment of nearly Rs. 24,000 crore over the next five years. Additionally, the MEG and PTA production sectors will require investments of around Rs. 40,000 crore.

If the government does not remove the inverted duty structure, it will severely affect these investments.

At present, with the United States imposing a 50% tariff on Indian products, the export of yarn from many Indian manufacturers to the US will come to a halt. Industrialists expressed concern that if domestic yarn producers lose competitiveness under these circumstances, imports of textile products into India will increase significantly.

Representatives from the Confederation of Indian Textile Industry, SIMA (Southern India Mills Association), MATEXIL (SRTEPC), Nylon Spinners Association, the Textile Association of New Delhi, Association of Synthetic Fibre Industry, Polyester Textile Apparel Industry Association, PDEXCIL, and PTA User Associations participated in the online meeting

Sangeetaben Patil, Dr. Mehul Shah, Gujarat State President of the Indian Medical Association, Dr. Kishorsinh Chawda, Vice-Chancellor of Veer Narmad South Gujarat University, and Professor Dr. K.C. Poriya, Vice-Chancellor of Hemchandracharya North Gujarat University, attended as Guests of Honour.

President of the Chamber of Commerce, Nikhil Madrasi, stated that in India, 60% of deaths occur due to non-communicable diseases such as diabetes, hypertension, cardiovascular diseases, cancer and respiratory illnesses. With 11 crore people in India

currently living with diabetes, the Health Conclave was organized with the objective of promoting preventive healthcare.

Indian Medical Association's National President-Elect, Dr. Anil Nayak, said that while money can always be earned, health is the most important asset. After the age of 40, if you don't walk for 40 minutes a day, nothing in your life will 'walk' the way it should. Food intake should also be in proper measure.

The human body is made up of 70% water; therefore, one must drink plenty of water. A good 8 hours of sleep is essential. People tend to eat the most on fasting days, but the true meaning of fasting is not abstaining from food – it is coming closer to God. He added that if we take proper care of our health, we will rarely need a doctor. One must stay stress-free, because whatever we already have is our real profit. Maintaining a positive attitude and good behaviour is equally important.

MLA Smt. Sangitaben Patil stated that if individuals are not healthy, society becomes weak – and a nation with a weak society can never progress. Doctors play a vital role in keeping the community healthy. She emphasized the need to spread awareness about good

health among people, especially motivating those living in rural areas. Major General Shamsher Singh Ahlawat (Retd.), Advisor, NICDC Logistics Data Services, graced the event as the Chief Guest.

Chamber President Nikhil Madrasl stated that the global Artificial Intelligence market is expected to exceed USD 1 trillion by the year 2030.

India alone is estimated to contribute more than USD 500 billion to its GDP through Artificial Intelligence by 2035. India's digital economy is also

advancing rapidly and is projected to reach USD 1 trillion by 2030. Initiatives such as ONDC and ULIP will greatly strengthen MSMEs and start-ups.

The cloud computing market in India is expected to reach USD 17.8 billion by 2027, providing even small businesses with opportunities to grow at a global level. By adopting Industry 4.0 technologies in the manufacturing sector, the productivity of Indian factories is projected to increase by up to 25% by 2030. In today's Industry 4.0 era, MSME entrepreneurs, start-ups, and traditional industries must move beyond 'best practices' and embrace 'next practices' to stay ahead.

General Shamsheer Singh Ahlawat (Retd.), Advisor at NICDC Logistics Data Services, shared insights on NICDC's ULIP (Unified Logistics Interface Platform) and LDB (Logistics Data Bank). He stated that nearly 50 lakh containers are searched on the LDB portal every month. NICDC also provides extended services for domestic and coastal containers across 16 terminals, enabling the tracking of 100% EXIM containers in India (covering 90% of the total container volume).

ULIP is a key initiative under PM Gati Shakti, launched by the Hon'ble Prime Minister on 17th September 2022 as part of the National Logistics Policy (NLP). All modes of logistics—waterways, air, rail, and road—are integrated under ULIP, covering containerised cargo, break-bulk cargo, and more. He also guided the entrepreneurs and business community of South Gujarat on Public Infrastructure for Logistics.

Additionally, he provided an in-depth

explanation of the digitalization of the supply chain and logistics ecosystem.

Ms. Megha Bansal, Vice President - Supply Chain & Logistics, ONDC, Government of India, shared insights on digital commerce ecosystems. She stated that the number of sellers on e-commerce platforms in India is extremely low. Across the country, only about 5-6% of total purchases happen through digital commerce, while less than 2% of MSME entrepreneurs sell their products online.

ONDC is an open network that shifts e-commerce from a platform-centric model to a network-based model. Until now, buying and selling primarily took place only through large platforms like Amazon and Flipkart. However, ONDC enables any seller, buyer, and service provider to connect within a single interoperable network.

Minesh Mohile, Chief Technology Architect at Metal & Precious Stocks, explained the journey from

Transformation for Next-Generation Technology', Sanjeev Sharma, Director - Tech Sales & Partner CTO at Microsoft, stated that this is not just India's decade – It is India's century. A guidance session on the reforms made in GST 2.0



The amendments introduced in GST 2.0 will directly benefit consumers through price reduction, significantly ease the burden on the healthcare and insurance sectors, and relieve small traders from excessive paperwork. However, clarity is still awaited regarding the textile and footwear sectors, as well as on cess ITC, said Chartered Accountant experts

The Southern Gujarat Chamber of Commerce & Industry organized a guidance session on the amendments introduced in 'GST 2.0' on Wednesday, 17th September 2025, at 4:00 p.m. at Sanhati, Sarsana, Surat. CA Nitesh Jain, Managing Partner at NJ Jain & Associates; CA Rashmin Vafa, Partner at Kandhar Mehta & Shah; and CA Purit Prajapati, Founder of Purit Prajapati & Co., provided detailed insights on the benefits that the GST 2.0 amendments will bring to consumers, businesses, and industries.

Chamber of Commerce President Mr. Nikhil Madraai stated that GST 1.0 has established itself as a historic reform in the Indian economy. The new reforms under GST 2.0 will now lead industries towards greater transparency, simplicity, and efficiency. These reforms are crucial—enabling large industries to remain competitive in the global market and helping small enterprises strengthen their competitiveness. He further added that to ensure that entrepreneurs in Surat gain a proper understanding of the new tax framework and

can implement it smoothly, the Chamber will continue to organise such guidance sessions in the coming days.

CA Nitesh Jain, CA Rashmin Waja, and CA Punit Prajapati discussed the practical implementation of the new GST rules and the benefits expected for industries. The chartered accountant experts stated that the Government of India has announced several major GST reforms that will come into effect from 22 September and 1 October 2025. These changes will have a direct impact on common consumers, small traders, and industries.

Under GST 2.0, the tax structure has now been simplified to just two core rates:

- 5% GST on essential commodities
- 18% GST on most goods and services
- 40% GST on luxury items

With GST 2.0, essential goods will now become cheaper. In the agriculture and handicraft sectors, tractors and fertilizer chemicals have been placed under the 5% GST slab, offering significant relief to farmers and artisans.

Clarifying the concerns of traders, the chartered accountant experts stated that traders are not required to change the printed MRP on old stock, but re-labelling will be mandatory. If tax rates are reduced, the benefit must be passed on directly to consumers. It is compulsory for businesses to ensure that the reduction in GST rates reflects in the final consumer price. If companies retain the benefit instead of passing it on to customers, strict action will be taken. They further explained that compensation cess has been removed from several products. However, clarity is still awaited regarding the input tax credit on cess already paid for old stock.

Under the new system, post-sale discounts will no

longer attract double taxation. The benefit of discounts received by the customer will directly reach them, and traders will not face any additional burden. The reforms introduced under GST 2.0 will provide consumers with immediate price reduction benefits, while significantly reducing the burden on the healthcare and insurance sectors. Small traders will also get relief from excessive paperwork. However, clarity is still awaited regarding the textile and footwear sectors, as well as on the issue of cess ITC.

The chartered accountant experts further stated that uncertainty still persists in the textile and footwear sectors. Although GST rates have been reduced on most goods, the higher tax rate on job work remains unchanged, which continues to create an inverted duty structure. Under ISD, no ITC refund is available on input services such as job work, logistics, and packaging, and government clarification on refunds in such cases is still awaited. Traders with an annual turnover of up to ₹2 crore will no longer be required to file returns. Newly registered businesses will now receive GST registration approval within just three days. Additionally, appeals in all cases will now be heard by a single-member bench.

The Chamber's Hon. Secretary Mr. Bijal Jariwala, Hon. Treasurer CA Mitish Modi, along with industrialists, business professionals, CA practitioners and students were present at the session.

The Chamber's Group Chairman, CA Hardik Shah, outlined the structure of the session. The Chamber's GST Committee Chairman, Mr. Mukund Chauhan, conducted the entire session. Chamber member CA Shailesh Lakhankiya proposed the vote of thanks and expressed gratitude to all attendees.

A delegation of 20 industrialists visited textile units in Tiruppur, Karur and Erode in South India



During the meeting with the office-bearers of the Tiruppur Exporters' Association, discussions were held on policy-related representations to the Central Government, increasing the export of MMF textile products from Surat, the availability of textile raw materials, the impact of U.S. tariffs, and strategies to address these challenges

A 20-member delegation of industrialists from The Southern Gujarat Chamber of Commerce & Industry visited textile units in Tiruppur, Karur, and Erode in South India to gain insights into the industry and its business ecosystem. During the visit, the delegation toured two CFC centres-SIMCO (Tiruppur) and AIC NIFTEA-as well as two major industrial units: Technosportwear Pvt Ltd. in Erode and ASIAN FABRIX Pvt Ltd. in Karur. Meetings were also held with the Tiruppur Exporters' Association and the Karur Textile Manufacturers Exporters' Association, where both sides agreed to sign an MoU to foster mutual cooperation for the development of their respective industries.

On 16 September 2025, the Chamber's delegation met with office-bearers of the Tiruppur Exporters' Association, where discussions on mutual cooperation were held. Key topics included policy-related representations to the Central Government exploring how the Tiruppur Exporters' Association could support the export of MMF textile products from Surat, the availability of textile raw materials, the impact of U.S. tariffs, and strategies to address these challenges.

In addition, the discussion also focused on boosting exports to countries other than the United States. During the meeting, both the Tiruppur Exporters' Association and The Southern Gujarat Chamber of Commerce & Industry expressed their

willingness to collaborate for the growth of their respective industries.

The Tiruppur Exporters' Association assured that they would guide MMF manufacturers in Surat on how to export their products, share export inquiries with Chamber members, and also extend support in facilitating exports on their behalf.

The delegation also visited the CFC established by the South India Imported Machines Knitters Association in Tiruppur. This CFC center supports micro and small enterprises in Tiruppur with product development, research & development, and sample creation. The delegation further visited the exhibition organized by the India Knit Fair Association, where Surat-based industrialists interacted with Tiruppur exporters and exchanged business inquiries.

AIC NIFTEA provides research, product development, design development, and skill-development training in the garment sector, and supplies nearly 700 skilled graduates and post-graduates to the industry every year. One of the institute's students founded the company Technosportswear Pvt. Ltd., whose plant was also visited by the Chamber's delegation. This company has earned a strong reputation in India's sportswear

sector and has invested Rs. 150 crore under the Central Government's PLI scheme. In just two years, the company has achieved an annual turnover of Rs. 450 crore. The plant handles the complete production process – from weaving to finished garments – and is equipped with an ultra-modern Zero Liquid Discharge (ZLD) facility.

In Karur, the delegation visited ASIAN FABRIX Pvt. Ltd., India's second-largest textile company in the home-textile segment, which is also a primary vendor for IKEA, the world's largest home-furnishing brand. The company operates with ultra-modern technology and manages the entire production cycle – from yarn manufacturing to the creation of fully finished home-textile products.

The representatives of both companies handed over samples of MMF fabrics that are currently being imported from China and informed the Surat industrialists that if these MMF fabrics are manufactured in Surat, they would procure the fabrics directly from Surat-based producers. They also assured that any inquiries they receive would be shared with Surat's entrepreneurs. The company officials expressed a strong willingness to fully support Surat's textile industry in achieving new heights and expanding its capabilities.

The Chamber submitted a written representation to the Union Finance Minister of India and the Chairman of the CBDT, requesting an extension of the deadline for filing Tax Audit Reports for the financial year 2024-25, as well as for the renewal of registrations of Public Trusts and Societies

The Southern Gujarat Chamber of Commerce and Industry has submitted a written representation to the Union Finance Minister, Smt. Nirmala Sitharaman, and the Chairman of the Central Board of Direct Taxes (CBDT), Ravi Agrawal (IRS), requesting an extension of the due dates for filing Tax Audit Reports for the financial year 2024-25, as well as for the renewal of registrations of Public Trusts and Societies.

Chamber President Mr. Nikhil Madrasī stated that although the deadline for non-audit filers has been extended, taxpayers and businesses falling under

tax audit are still facing recurring challenges such as technical glitches on the portal, delayed release of the final ITR utility, multiple changes in formats, and a significantly compressed calendar of only eight working days. If these issues remain unresolved, there is a high possibility of errors in submissions, which would then require subsequent corrections. This will increase administrative burden and adversely affect the quality of compliance. Considering these difficulties, the Chamber has requested that the due date for filing Tax Audit Reports and related returns be extended to 31st December, 2025.

The Southern Gujarat Chamber of Commerce & Industry recently organized an interactive session at Samruddhi, Nanpura, Surat on opportunities in export-import, where experienced exporter, international trade expert and corporate trainer Mr. Amit Mulani shared in-depth insights with exporters.

Chamber President Mr. Nikhil Madrasai stated that the industries of Surat and South Gujarat are now poised to make a strong mark globally. The export-import sector offers immense opportunities, but without proper guidance and effective communication strategies, these opportunities cannot be fully utilized. The purpose behind organizing such interactive sessions is to equip entrepreneurs and exporters with the knowledge and skills required to successfully enter international markets. This initiative will make industries more competitive and help position Surat as a global trade hub.

Experienced exporter, international trade expert and corporate trainer Mr. Amit Mulani stated that in today's global era, the demand for Indian products has not diminished. From textiles to jewellery and natural stones, the quality of Indian products is appreciated worldwide. Yet, many exporters still struggle to convert inquiries into actual deals. Despite having quality products, Indian

exporters often face difficulties in converting global buyers due to a lack of proper communication.

He explained that platforms like LinkedIn, international trade fairs, and B2B portals make it easy to find buyers, but weak pitching, poor follow-up, and a lack of understanding of buyer psychology cause most exporters to lose out on closing deals. Many exporters assume that finding a buyer means the job is done, whereas, in reality, that is only the beginning.

Mr. Amit Mulani said that global buyers look for trust. If your pitch is unclear, your communication lacks structure, or you disappear after the first message, you lose the deal even before it begins. The toughest part is not finding a buyer – it is building trust and consistently presenting your value. Even small-scale exporters can build long-term international relationships if they adopt a professional approach and maintain discipline in their follow-ups.

He further said that while product quality opens the first door for exports, it is communication, consistency, and an understanding of the buyer that keeps that door open. India's true export potential will be unlocked only when businesses combine the strength of their products with the right global mindset.

The Southern Gujarat Chamber of Commerce and Industry submitted a written representation yesterday to the Industries Commissioner, requesting allocation of funds for disbursing the pending amounts of claims approved under the "Gujarat Scheme for Assistance to Specific Sectors of the Textile Value Chain - 2019".

Chamber President Mr. Nikhil Madrasi stated that in the representation submitted to Gujarat's Industries Commissioner, Mr. Swaroop P. (IAS), the Chamber has pointed out that every year, before Diwali, the Industries Department clears the backlog

of subsidy files under various industrial policies. However, under the "Gujarat Scheme for Assistance to Specific Sectors of the Textile Value Chain - 2019," no funds have been allocated so far for claims approved after February 2024.

In the representation submitted to the Industries Commissioner of Gujarat, it has been stated that the pending amount of approved claims under the above scheme is approximately ₹500 crore. Therefore, the Chamber has requested that funds be allocated at the earliest to the concerned industrial units so that this large backlog can be cleared before Diwali.

Concern for workers health, SGCCI in collaboration with the Ministry of Environment and other organizations conducted an awareness session



The Southern Gujarat Chamber of Commerce & Industry (SGCCI), in collaboration with the Ministry of Environment, Forest & Climate Change (Government of India), the Indian Council of Medical Research (ICMR), the National Institute of Occupational Health, and Aajeevika Bureau, organized an awareness session on "Impact of Air Pollution, Noise Pollution, and Heat Stress on Workers' Health" on Tuesday, 23 September 2025 at 6:30 PM at Sanhati, Sarsana, Surat.

During the welcome address, SGCCI's Hon. Secretary Mr. Bijal Jariwala said that the Chamber consistently organizes awareness programs that deliver meaningful guidance. He noted that this session is especially important, as it will help industries adopt the right direction and become more sensitive towards workers' health and well-being.

Mr. Sanjay Kotadia, Technical Officer, ICMR-National Institute of Occupational Health, explained

In detail the effects of noise pollution and excessive heat on the human body. He stated that not only loud industrial machines but also the use of earphones and headphones can adversely impact hearing. In Surat's embroidery and weaving sectors, machines generate high noise levels, affecting nearly 30% of workers. He elaborated on temporary and permanent hearing loss caused by noise pollution and emphasized that while temporary damage can often be prevented with precautions, permanent hearing loss is irreversible.

He added that if workers need to shout even from a distance of just three feet, it indicates a high-noise work environment. In such cases, the use of hearing protection devices becomes essential. He also pointed out that noise pollution affects us outside the workplace as well – for instance, passing near loud DJ speakers can increase heart rate. Prolonged use of headphones can cause ear infections, which may even affect the brain since ears are directly connected

to it. He explained how their institute measures noise levels using advanced tools like personal noise dosimeters.

Mr. Mohammad Idrish Shaikh, Technical Assistant at ICMR-NIOH, explained the harmful effects of air pollution, the pollutants responsible, their health impacts, and ways to reduce exposure.

Mr. Kunhal Shah, Chairman of the Chamber's Environment, Pollution Control & Waste Management Committee, outlined the purpose of the program and stated that factors like coal usage and high-noise machinery in industries significantly impact workers' health – often without workers

realizing long-term consequences. Therefore, protecting workers' health is equally important.

Ms. Parul Vats, Program Officer, and Mr. Ajay Neerje, Information Officer from the National Institute of Occupational Health, Ahmedabad, shared details about the Environmental Information, Awareness, Capacity Building & Livelihood Programme.

"We all know that waste increases with development but the real question is—Is waste only a burden? Or can it become an opportunity for us? Today, the 'Circular Economy' has shown that waste is not a problem but a resource. If utilized correctly, it can help protect the environment, open new avenues for industries, and most importantly, build a sustainable future. Recycling industries, waste-to-energy units, plastic pelletizing plants, and textile recycling projects create employment and new business opportunities, strengthening the local economy."

Neha Modi said: "Australia is the world's

largest consumer of textiles per capita. Surprisingly, only 8% of its textile imports come from India. Like Australia, India too needs to focus more on textile recycling. When a product is recycled and prepared for reuse, it is essential that the quality of the product is retained. Governments should consider introducing incentive-based policies mandating at least 30% recycled material in packaging."

She further added: "In India, people still do not segregate dry and wet waste. This makes the recycling process more difficult. Even children need to be educated about this from an early age so that waste segregation becomes a habit. With proper recycling systems, landfill gas, food waste, and industrial waste can be transformed into new energy sources. Biogas, hydrogen, and renewable diesel are emerging as strong alternatives to traditional fuels."

Mr. Devkishan Manghani, Chairman of SGCCI Global Connect Committee, conducted the entire session.

Ms. Neha Modi also responded satisfactorily to all questions raised by the participants. The session concluded thereafter.

A 'Civil Defence – A Necessity' awareness session

The Southern Gujarat Chamber of Commerce & Industry organised an awareness session on 'Civil Defence – A Necessity' on Friday, 19 September 2025, at 5.00 pm at Samruddhi, Nanpura, Surat. The keynote address was delivered by Kanji Bhai Bhalala, former Chief Warden of Surat Civil Defence and President of Saurashtra Patel Seva Samaj. He explained in detail the difference between self-defence and civil defence.

In his welcome address, the Chamber's Group Chairman, Paresh Lathiya, highlighted the growing need for civil protection in light of the recent geopolitical and war-like situations. He stated that civil defence originated during World War II in 1941, proved its importance during the 1962 and 1965 wars, and was formally enacted through legislation in 1968. The Civil Defence unit in Surat was established in 1997, and in 2009, its scope was expanded to include natural and man-made disasters.

Kanji Bhai Bhalala emphasised that industries must recognise the importance of civil defence, especially in modern times when warfare technologies have dramatically shifted. He said,

"Today, after arrows, cannons and missiles, we have entered the age of drones. Well-informed and alert citizens form the first and strongest line

of defence during wars and disasters. Citing the 2001 earthquake, he explained how misinformation had caused many deaths. Civil defence, he said, aims to protect lives and minimise losses through awareness, preparedness and correct guidance.

He also shared detailed information on how citizens and industries can participate in civil defence activities. Surat is classified among the 40 most critical locations in India for civil defence due to the presence of Kakrapar Atomic Plant, Ukai Dam, and major industrial zones in Hazira. He appreciated the Chamber for hosting a programme on such a vital subject. Since Operation Sindoor, Civil Defence has once again come into focus. The role of Civil Defence is to save lives, minimise damage to property, restore essential supplies at the earliest, and maintain public morale during disasters.

The Chamber's NGO Committee Chairman, Mohammed Naved Shaikh, urged all attendees to undergo civil defence training and announced that civil defence units will soon be established in every college.

The Ministry of Textiles, Government of India, in association with The Southern Gujarat Chamber of Commerce & Industry (SGCCI) and MATEXIL, conducted a meeting with textile industrialists on 25 September 2025 at Sanhati, Sarsana, Surat. During the meeting, Mr Bhaskar Kalara, Under Secretary, Ministry of Textiles, Government of India, who had specially come from New Delhi, provided detailed information about the PLI Scheme and also gathered suggestions

from Surat's textile entrepreneurs.

Under Secretary Mr Bhaskar Kalara from the Ministry of Textiles, Government of India, provided detailed information to the textile industrialists about the benefits of the PLI Scheme. At present under this scheme, textile units making an investment between ₹100 crore to ₹300 crore, as well as those investing above ₹300 crore, are eligible for incentives. A total of 116 HSN codes are covered under the scheme. He informed

that the application window for availing the scheme benefits is open until 30th September 2025, and urged industrialists to apply at the earliest. He also invited suggestions and feedback from the industry regarding the scheme.

In this meeting, Chamber of Commerce Hon. Secretary Mr. Bijal Jariwala, METEXIL's immediate past Chairman Mr. Dhiraj Shah, FIASWI Chairman and former Chamber President Mr. Bharat Gandhi, Pandesara CETP Chairman Mr. Ravindra Arya, the Chamber's former President and Chairman of the Chamber's Textile Task Force Mr. Ashish Gujarati, as

well as other textile industrialists were present.

Under the PLI scheme, only textile entrepreneurs investing between Rs 100 crore to Rs 300 crore and above Rs 300 crore are currently eligible for benefits. Therefore, the textile industry stakeholders suggested that the scheme should also extend benefits to entrepreneurs investing up to Rs 50 crore. In addition, they recommended that new HSN codes be incorporated into the scheme. Furthermore, the industry representatives urged the Ministry of Textiles' Under Secretary, Mr. Bhaskar Kalra, to include import-substitute textile products within the scope of the scheme.

Mantra Director Dr. Anup Rakshit briefed the industrialists about the objectives of this programme.

In his keynote address, Mr. Neeraj Mithani, Director of Aeolus Sustainable Bioenergy Pvt. Ltd. highlighted how ReEM can play a crucial role in achieving environmental compliance and sustainability. He explained practical applications, technological advancements, electro-oxidation methods, and shared industry case studies. He stated that, just like the Emission Trading Scheme, Surat has become the first city in the country to implement the Effluent Trading

Scheme from this year. There are several economical and simple technologies through which industrial wastewater can be effectively treated. He further explained how these technologies are highly effective not only in the textile sector, but also in sugar, molasses, pharma, and power industries. He added that removing colour from wastewater is relatively easy with the right treatment approach.

In such cases, ECGC's insurance schemes help MSMEs establish themselves in the global market and increase their export business." He provided detailed information on the Standard Policy, Specific Shipment Policy, Small Exporter Policy, Buyer's Credit Insurance Policy, and Export Credit Insurance to Bank Policy.

The Chamber of Commerce's Vice President Mr. Ashok Jirawala, Hon. Secretary Mr. Bijal Jariwala, Hon. Treasurer CA Mitish Modi along with several industry entrepreneurs, were present at the session. At the end, the speaker addressed all the queries raised by the participants satisfactorily.

Emotional Wellness is the ability where a person can recognize their emotions, express them healthily, and maintain balance.

It arises from injustice, insult, failure, or when desires are not fulfilled, but uncontrolled anger can cause stress in relationships, obstacles in work, and health problems. The Southern Gujarat Chamber of Commerce and Industry organized a power session on 'Nurturing Startups: Building Resilience and Scaling New Horizons' on Saturday, September 27, 2025, at 5:30 PM at Samruddhi, Sarasana, Surat, where Former Indian Army Chief General Manoj Mukund Naravane (Retired) and India Accelerator Founder and CEO, as well as Finvolve VC Co-Founder Ashish Bhatia, provided important guidance to Surat's entrepreneurs and startup businesspersons.

Chamber of Commerce Hon. Minister Bijal Jariwala, in his welcome address, stated that to achieve success, one must rise before the sun and run like a horse. Chamber Hon. Treasurer CA Mitish Modi, outlining the program, said that India's startup and unicorn ecosystem is developing rapidly, yet 90% of startups fail. However, the future belongs to startups.

Former Indian Army Chief General Manoj Mukund Naravane (Retired) provided guidance to entrepreneurs and startup businesspersons on resilience, discipline, and strategic planning on 'The Cost of War: Strategic and Financial Lessons for India's Startup Ecosystem'. Explaining the cost of war, he said that war should be the last option, not the first. Speaking on self-reliance in defense, he said startups also have a major role

to play in defense. We still have to buy airplanes from abroad. Battles are now between drones and anti-drone systems. He advised startups to focus on effective alternatives and solutions.

Ashish Bhatia provided guidance to startups on 'How India Accelerator Can Turn Surat into Silicon Valley?'. Supporting the help startups are getting for rapid growth at the international level through guidance, networking, and capital from investors, he shed light on how Surat's entrepreneurial ecosystem can be expanded. Comparing startups to making burgers, he said that 25% of the world's unicorns are in Silicon Valley. Surat ranks only 15th in the country's startup ecosystem, but now 45% of startups are happening in Tier 2-3 cities. Surat is the world's fastest-growing city. All components for developing a startup ecosystem in Surat are present in Surat, which polishes 90% of diamonds, is now ready to polish the world's startups.

Chamber member Samkit Shah and Chamber's Income Tax Committee Co-Chairman Advocate Anil Shah introduced the speakers. The entire session was conducted by program convener Dharmesh Mehta. Both speakers resolved various confusions of young entrepreneurs in the Q&A session. Chamber Deputy Secretary Paulik Desai thanked all and concluded the session.

The country's economy is continuously advancing, and in the coming times, 85% of the country's GDP will come from cities. Cities and urban planning will play an important role in the country's economic system. In terms of urban planning, Surat has set an example for the country. In

water recycling and reuse, Surat city and the textile sector have also set an example, generating Rs. 140 crore in revenue for Surat Municipal Corporation. Surat is also leading the entire state in solar rooftops. Surat has become the first city in the country to run 100% electric buses on the BRTS corridor.

She said that both the central and state governments emphasize urban infrastructure. The Rs. 200 crore green bonds are for people's participation in environmental projects. Awareness Session on Regenerative Medicine



Stem Cells Can Bring Regenerative Power, In the Near Future Teeth Will Regrow, No Need for Implants, Child's Education Should Start from One and a Half Years of Age: Dr. Pradip Mahajan



The Southern Gujarat Chamber of Commerce and Industry organized an awareness session on 'Cutting-Edge Science of Regenerative Medicine - Touching Chronic Disease and Anti-Aging' on Sunday, September 28, 2025, at 10:30 AM in Samruddhi, Nanpura, Surat, where Maharashtra Bhushan Award winner and pioneer in regenerative medicine, as well as founder of StemRx Bioscience Solutions Pvt. Ltd., Dr. Pradip Mahajan provided useful guidance.

Dr. Pradip Mahajan shed light on the progress in cutting-edge regenerative medicine in stubborn diseases and anti-aging, stating that nature has given humans only healing power; we can bring regenerative power. Now, after 45 years of age, women can produce eggs. Our body has its own repairing kit.

Explaining this complex science in simple language, he said that from one cell a body of 150 trillion cells is formed, 222 organs are formed. Master cell, i.e., stem cell, stores our genetic information. Aging is a wrong belief; it is not natural but a disease. When you go to any hospital or surgeon and don't find a solution, that's when my role starts. My words may seem like miracles to you, but they are facts. Today, this science has advanced so much that age can be reversed, embryos can be recreated from cells.

Technology is at hand where teeth can regrow, no need for implants.

He said that in organ transplants, there are higher chances of rejection (body not accepting). With stem cells, regrowing organs doesn't pose this problem. He explained how eyesight deteriorating due to diabetes can be regained. Citing science, he said that a child's education should start when they are one and a half to two years old because at that time neurons are most connected, and we don't have to teach them; that's why in earlier times, a child was sent to gurukul at two years old.

He explained the science behind living a centenarian life without paracetamol and antibiotics. Science is advancing to the extent that we will live so long that we get bored. Immortality is impossible today; instead of a boon, he emphasized the need to increase healthy lifespan and explained age management.

Chamber Group Chairman Rakesh Gandhi gave the welcome address. Chamber's Industrial Worker Health Committee Chairman Dr. Jagdish Vaghasiya outlined the program. While Chamber's Public Health Committee Co-Chairman Dr. Sonia Chandani introduced the main speaker and thanked all present in the program.
