Business delegation's visit to Botswana opens new doors for bilateral cooperation



Under the auspices of The Southern Gujarat Chamber of Commerce and Industry (SGCCI), a business delegation of entrepreneurs and industrialists from Surat visited Gaborone, the capital of the Republic of Botswana, from November 10 to 14, 2025. This business delegation's visit took place during the visit of the Honorable President of India, Smt. Draupadi Murmu, to Botswana.

This business delegation included Mr. Nikhil Madrasi, President of The Southern Gujarat Chamber of Commerce and Industry; Mr. Brijesh Dholakia of Hare Krishna Group; Dr. Faruk Patel of KP Group; Mr. Roby Rajasekharam of KPI Green Hydrogen; Mr. Darshak Narola of Shree Ramkrishna Exports; Mr. Hitesh Shah of Venus Gems; Mr. Jayanti Savaliya and Mr. Rajat Wani of the Gem and Jewellery Export Promotion Council; Mr. Gurmeet Singh Maan and Mr. Rakesh Shah of Taranjyot Energy; Mr. Dinesh Dhankani of Liberty Group and Reaghan Fashions Pvt. Ltd.; Mr. Milan Parikh of Jainam Shares; Mr. Deepak Sheta of Apple Lifestyle Industries Limited;

Mr. Krunal Mehta of Mehta Wealth; and Fenil Patel of Rayzon Solar.

The Chamber of Commerce delegation was welcomed by Indian industry leaders in Botswana and held meetings with local business authorities. These meetings were organized by Mr. Ashit Mehta, Chairman of the Botswana-based Blue Star Group. During these sessions with local industry leaders, detailed discussions were held regarding Botswana's economic factors, business structure, and corporate culture, as well as the potential for bilateral cooperation and investment across various sectors.

On November 11, 2025, an important meeting was held between the Chamber of Commerce's delegation and the Botswana Investment and Trade Centre (BITC), attended by BITC Executive Director Ms. Trunclina Gabontone and senior departmental heads from various sectors. The Executive Director of BITC stated that the center would serve as the primary focal point for business-related investments for the Chamber members. During this meeting, vast



opportunities for investment and cooperation were presented in sectors such as diamond and mineral processing, mining (coal, copper, soda ash), power generation (solar, biofuel), and railway infrastructure development.

A meeting was held between the Chamber of Commerce delegation and the Botswana Ministry of Minerals and Energy, which was attended by senior advisors of the ministry. During this meeting, Surat's entrepreneurs were primarily invited to actively participate in the expansion of Botswana's mining sector.

A meeting was held with the Non-Bank Financial Institutions Regulatory Authority (NBFIRA), attended by the Authority's Chief Executive Officer, Ms. Verily Molatedi, and the Director of Capital Markets, Ms. Juliana White.

The Chamber's business delegation was briefed on the regulatory framework for non-banking financial institutions in Botswana, as well as the operational structure and policies of the Botswana Stock Exchange. Discussions were held regarding interest rates for business investment loans and deposits, new possibilities in the fintech sector, and real-time transaction systems.

Mr. Nikhil Madrasi, President of the Chamber of Commerce, presented a detailed vision of the Chamber to further strengthen bilateral trade between India and Botswana. He specifically emphasized enhancing cooperation for the

necessary arrangements for Ease of Doing Business, partnerships in the diamond industry, textile sector, and renewable energy field, as well as ensuring the security and reliability of trade and investment.

High-level meetings were held between the Chamber's delegation and key organizations associated with Botswana's diamond industry, such as the Okavango Diamond Company (ODC), KGK Diamonds, and officials from the Kimberley Process. These meetings involved deliberations on cooperation regarding diamond trading and its expansion, certification processes, and skill development exchange programs, including training between India and Botswana. Furthermore, joint possibilities to further strengthen the India-Botswana diamond value chain were discussed. Through these meetings, deep cooperation and new opportunities in the diamond sector between both countries were promoted.

A grand state reception was organized by the Honorable President of Botswana, Advocate Duma Gideon Boko, in honor of the Honorable President of India, Smt. Draupadi Murmu. This event was integrated with her official state visit to Botswana. The Chamber of Commerce's delegation was extended a special invitation to this prestigious ceremony.

Botswana's President, Honorable Advocate Duma Gideon Boko, warmly welcomed India's Honorable President Smt. Draupadi Murmu and



expressed Botswana's commitment to further strengthening the India-Botswana bilateral partnership. President Boko provided detailed information regarding the country's priorities for Botswana's economic transformation and, making a significant announcement, stated that Botswana will gift 8 cheetahs to India. This gesture will be regarded as a symbol of the growing friendship between the two nations. He further expressed hope that this heart-touching gesture would attract more Indian tourists to Botswana, allowing them to gain a unique experience of the country's wildlife heritage and natural beauty.

Honorable President Smt. Draupadi Murmu expressed her heartfelt gratitude for the excellent gift presented by the Government of Botswana. She reaffirmed India's commitment to further strengthening multi-sectoral cooperation between India and Botswana. She praised Botswana's progress and extended full support to advance cooperation in priority sectors identified by India. Detailed discussions were held regarding bilateral cooperation in areas such as trade and investment, renewable energy, digital public infrastructure, agriculture and food processing, healthcare and pharmaceuticals, skill development and capacity building, defense, mining, and cybersecurity. Botswana showed a special interest in India's digital public infrastructure model.

On November 13, 2025, a meeting was held

with the Chamber's delegation at the Office of the President of Botswana, which was attended by President Advocate Duma Gideon Boko, the Minister of Trade and Industry, the Principal Secretary to the President, the Botswana High Commissioner to India, and the CEO of BITC. Chamber President Mr. Nikhil Madrasi expressed special gratitude for the excellent hospitality and well-coordinated arrangements provided by the Government of Botswana. He also praised the historic 4-hour economic roadmap presented by the President in Parliament on November 10.

The Twin City proposal for Surat and Gaborone was presented, involving discussions on urban development, technology and talent exchange, medical tourism, education, student exchange programs, and the regular exchange of business delegations and exhibitions. The Chamber's delegation also put forward representations regarding long-term business visas, a single-window system, land allocation for Indian investors, and 100% FDI in mining, finance, and technology sectors. Furthermore, an invitation was extended to the President of Botswana and the Cabinet to attend the SGCCI's Global Village 2026, which is to be organized by the Chamber of Commerce in Surat from January 24 to 26, 2026. The President of Botswana praised the Chamber's various activities, its leadership, and the efforts being made for the development of trade and industry in South Gujarat.

He supported cooperation in the stock exchange and fintech sectors. He encouraged Gujarati entrepreneurs to explore tourism opportunities in Botswana. Providing assurances regarding the safety and security of Indian investors, he described India as a long-term development partner. Additionally, he praised the Chamber's commitment toward Botswana.

Honorable President of India, Smt. Draupadi Murmu, addressed the Indian diaspora living in Botswana at an Indian Community Meeting organized by the High Commission of India in Gaborone. Discussions focused on investment in key sectors such as retail, mining, diamonds, construction, hospitality, finance, and renewable energy. Local entrepreneurs assured the Chamber's delegation of full cooperation regarding local market entry, regulations, and investment facilitation.

SITEX-2025 dazzles Sarsana, showcasing the future of textile machinery

As the third major exhibition of the year 2025-26 in the series organized by SGCCI, the SGCCI Trade & Industries Development Center, and the Surat Texmac Federation, 'SITEX-2025' was held from November 22 to 24, 2025, between 10:00 AM and 7:00 PM at the Surat International Exhibition and Convention Center in Sarsana.

The inauguration ceremony of SITEX Expo took place on Saturday, November 22, 2025, at 11:00 AM, where Mr. Dakshesh Mavani, the Mayor of Surat, attended as the chief guest and inaugurated the expo.

In his address, Chamber President Mr. Nikhil Madrasi stated that the SITEX exhibition is a vital platform accelerating the growth and global connectivity of Surat's textile industry and overall businesses. Surat city is a national leader in the textile

sector, and in the coming times, modern machinery and new technology will bring about a massive transformation in the industry. The innovations adopted by entrepreneurs will further strengthen Surat as a global textile hub.

Surat City Mayor Mr. Dakshesh Mavani stated that the textile industry, with its new machinery and modern technology, will play an extremely vital role in Surat's future development. Providing information about the PM MITRA Park near Surat, he stated that Union Minister Mr. C.R. Patil and Gujarat's Deputy CM Mr. Harsh Sanghavi are constantly striving for this park and are holding meetings to make it operational. He expressed confidence that infrastructure projects like the ongoing Metro Rail, Bullet Train, DREAM City, and the International Airport will significantly improve

Surat's connectivity and transport facilities. He stated that there is a plan to operate 100 flights from Surat within the next three to four months.

The Mayor expressed confidence that Surat's GDP will double in the next five years, as no other city in the country possesses a connectivity network as extensive as Surat's. He remarked that "Surat's sun is shining at its zenith," meaning that the city is progressing toward the peak of development. He praised the youth and entrepreneurs of Surat for constantly taking new initiatives. He also congratulated the Chamber for the proactive way it organizes various exhibitions and programs for the development of industries.

He added with pride that the reason Surat is called the number-one city in India is that it has received 15 national awards in the last one and a half years. Surat has ranked first in the country for air quality surveys and water sanitation, as well as in the model for recharging rainwater underground in the state of Gujarat. In the coming times, Surat will become the city with the fastest connectivity in the



country.

The Mayor mentioned that the Union Railway Minister of India has visited Surat three times in just one month to oversee the progress of the Bullet Train project. If any city is to benefit the most from the Bullet Train, it will be Surat, as facilities will be available to reach Ahmedabad and Mumbai in just one hour from Surat.

Furthermore, he stated that every fifteen days, a municipal corporation comes here to learn from and study the "Surat Model," including the municipal corporations of Hyderabad and Chandigarh.

Chamber Vice President Mr. Ashok Jirawala stated that the SITEX exhibition has been providing a business-to-business platform to industries for years, enabling Surat's textile industry to access new opportunities and markets at both national and international levels. The tradition of continuously encouraging entrepreneurs through such exhibitions and programs will be maintained by the Chamber in the future as well.

SITEX Expo-2025 generates an overwhelming response, with capital investment in textile machinery likely to exceed ₹2,000 crore within the next six months



More than 35,000 buyers and visitors from various corners of the country visited the SITEX Expo over three days, resulting in significant orders for the exhibitors

Mr. Nikhil Madrasi, President of the Southern Gujarat Chamber of Commerce and Industry, stated that feedback from exhibitors indicated SITEX Expo-2025 was a "super hit". All exhibitors were able to effectively present state-of-the-art machinery to buyers coming from cities across various states, and they also connected with new buyers. Exhibitors held one-on-one meetings with genuine buyers from across the country, during which the buyers placed substantial orders.

Furthermore, an analysis of the significant inquiries generated for exhibitors regarding state-of-the-art textile machinery and ancillaries suggests a strong potential for capital investment of more than Rs. 2,000 crore in textile machinery over the next six months. This is because SITEX Expo showcased advanced textile machinery manufactured in India alongside sophisticated textile machinery featuring

other international technologies.

On the first day of the SITEX exhibition, 9,450 buyers visited; on the second day, 15,380 buyers; and on the third day (Monday), 10,888 visitors came. Thus, a total of 35,718 visitors visited SITEX Expo over three days, providing extensive benefits to the exhibitors and the entire textile industry of Surat.

Matter raised with the Rajasthan Chief Minister following the attack on former President Mr. Ashish Gujarati near Udaipur

The Southern Gujarat Chamber of Commerce and Industry has made a representation to the Honorable Chief Minister of Rajasthan, Shri Bhajanlal Sharma, expressing grave concern regarding the attack on former Chamber President Shri Ashish Gujarati in the state of Rajasthan and requesting his intervention for appropriate legal action.

Chamber of Commerce President Mr. Nikhil Madrasi stated that on the night of October 26, 2025, around 11:30 PM in the Pipali area near Udaipur, former Chamber President Mr. Ashish Gujarati and his family were attacked by robbers armed with sticks. The attackers struck his head and issued death threats, leaving the entire family terrified and in a state of mental trauma.

Following this attack, Mr. Ashish Gujarati's family members immediately contacted the nearby Surajpole Police Station for help. However, the officers there refused to register a 'Zero FIR' citing jurisdictional issues. In its letter, the Chamber highlighted that the practice of registering a Zero FIR is accepted across India, allowing any police station to record a crime regardless of whether it occurred within its limits. Ultimately, higher-ranking officials extended their cooperation, and through their support, an FIR was finally registered three days later, on October 29, 2025.

The Chamber has also brought to the attention of the Rajasthan Government that due to the lack of

mobile network connectivity (specifically Vi service) across an approximately 50-kilometer stretch between Pipali and Udaipur, the victimized family was unable to seek immediate assistance. Furthermore, the emergency helpline number provided by the National Highways Authority of India (NHAI) remained unresponsive, leaving the family in a completely helpless state.

The Chamber has requested the Chief Minister to ensure a time-bound and impartial investigation of the incident, to apprehend the culprits and punish them legally, and to take appropriate action against the police officers who showed negligence in registering the Zero FIR. Additionally, they requested that security arrangements on the state's highways and tourist routes be further strengthened. Simultaneously, the Chamber has demanded improvements in mobile network connectivity, emergency helpline responsiveness, and highway communication infrastructure, so that such incidents do not happen to anyone else in the future.

The Chamber further stated that just recently, the Honorable Chief Minister of Rajasthan visited Surat and invited the industrialists of South Gujarat to invest in Rajasthan; however, such an unfortunate incident deals a blow to the confidence of the industrial world and also affects Rajasthan's image as a 'safe and investor-friendly' state.

Former President of Oman Chamber of Commerce visits SGCCI



Former President of the Oman Chamber of Commerce and Industry and entrepreneur Mr. Redha Juma Mohammed Ali Al Saleh visited the Chamber of Commerce on Wednesday, 5 November 2025.

As part of SGCCI's Global Connect initiative, he visited the Chamber and held extensive discussions with President Mr. Nikhil Madrasi and the office bearers regarding the expansion of business cooperation and people-to-people contact between India—specifically South Gujarat—and Oman. He also provided detailed information regarding investment opportunities in Oman and the incentives available for establishing industries there.

Mr. Redha expressed optimism that the Free Trade Agreement (FTA) between India and Oman is in its final stages and is expected to be signed by the end of this year, which would double the trade between the two nations. He suggested a strategic move: since Indian exporters, especially in textiles, are affected by U.S. tariffs, they could export via Oman. As Oman already has a Free Trade Agreement with the U.S., exporters from South Gujarat could leverage this to access the American market. He further highlighted that Oman offers Free Trade Zones and major ports like Sohar, Salalah, Duqm, and Port Sultan Qaboos in Muscat, which form a primary maritime network for international trade.

Pre-Budget Memorandum submitted to the Union Textile Secretary, highlighting key recommendations on GST, Customs, and Direct Taxes

The Honorary Treasurer of the Southern Gujarat Chamber of Commerce and Industry, CA Mitish Modi, and CA Rajeev Kapasiyawala met with the Union Textile Secretary, Neelam Shammi Rao (IAS), in New Delhi on Monday, November 3, 2025. During the meeting, they submitted a Pre-Budget Memorandum featuring key suggestions for the textile sector concerning GST, Customs, and Direct Taxes.

A delegation from the Chamber personally met with Mr. S.C.L. Das (IAS), Secretary of the Ministry of MSME, Government of India, in New Delhi to submit a representation regarding MSME issues. The Chamber proposed that the definition of 'Micro and Small Enterprises' under Section 15 of the current MSME Act should be expanded to include traders and retailers. This change would enable traders to also benefit from the provisions of Section 43(B)(h) of the Income Tax Act. The Chamber made this representation on the grounds that the original objective of Section 43(B)(h) was not being fully realized under the existing framework.

In addition, the Chamber delegation invited the Secretary of the Ministry of MSME, Mr. S.C.L. Das (IAS), to visit the Chamber in Surat and provide guidance to Surat's entrepreneurs regarding the Mutual Credit Guarantee Scheme for MSMEs (MCGS-MSME); he responded with a positive approach toward this invitation.

The Chamber's delegation also met with Shri Vaidya Rajesh Kotecha (IAS), Secretary of the Ministry of AYUSH, Government of India, in New Delhi.

An insightful seminar on 'Foodpreneurs: From Kitchen to Market'



The Southern Gujarat Chamber of Commerce and Industry (SGCCI) organized a seminar titled 'Foodpreneurs: From Kitchen to Market' on Thursday, November 13, 2025, at 5:00 PM.

The event featured industry experts including Mr. Himmat Patel from Taiyaba Food Products, Mr. Nitesh Shah from Maharana Foods, and Mr. Chandresh Raja from Raja Beverages Pvt. Ltd. They provided valuable guidance to aspiring entrepreneurs on business opportunities within the food industry, as well as critical topics such as marketing and branding.

Mr. Himmat Patel shared his inspiring journey,

stating that he started making chocolates without overthinking and gradually progressed in the business. He admitted that when he first began, he had no knowledge regarding the product, marketing, or packaging; he simply dived into the business with a strong determination to achieve something. He emphasized that if you create a product solely with the intention of earning money, you might not find success. However, if you do business with the mindset of establishing the product in the market and building it into a brand, success is certain. He advised never to compromise with the product, to maintain high standards, and to provide excellent

service and quality to customers. He concluded by saying that if a business delivers excellence in Packaging, Product, and Service, no one can defeat them in the market.

Mr. Nitesh Shah stated that while businesses are ultimately run to earn money, the highest importance must be given to product quality. He emphasized that quality should not only be maintained at the initial stage but must remain consistent throughout. He further highlighted the human element of business, stating that one should maintain excellent relationships with everyone involved—including traders, vendors, customers, and most importantly, employees. In today's market, where every product faces intense competition, he suggested that if we work through collaboration instead of competition, business growth is guaranteed.

Mr. Chandresh Raja, who is associated with the packaged water industry, sells bottled water under various brand names. Drawing from his own experience, he provided highly practical insights to the aspiring entrepreneurs. He shared a detailed account of his journey—how he successfully transitioned from the mobile phone business to establishing a foothold

in the water industry. He emphasized that to succeed in business, one must have a "burning fire" (intense passion) within. Furthermore, he discussed critical aspects such as understanding customer needs and developing robust strategies to thrive in a highly competitive market.

Mr. Yogeshbhai from Stuti Foods (Stuti Khakhra) shared a powerful perspective on business longevity. He stated that if you provide customers with a high-quality product and timely, excellent service, there is eventually no need for active marketing. He revealed that while they focused heavily on marketing for the first five years, their products have required zero marketing for the past ten years. Today, the brand is so well-established that orders are placed directly over the phone, and the supply is managed solely based on that existing trust and demand.

An awareness program on diabetes was organized as part of 'World Diabetes Day' under the joint auspices of The Southern Gujarat Chamber of Commerce and Industry (SGCCI) and the Indian Medical Association (IMA) - Surat. The event took place on Friday, November 14, 2025, at 6:30 PM at Samruddhi, Nanpura, Surat.

stated that, according to the ICMR 2023 analysis report, diabetes has already been diagnosed in 101 million people. Among those above the age of 45, nearly 19.8% are living with diabetes, which accounts for more than 50 million people. In Gujarat, an average of 8% of the population suffers from diabetes, while 10.5% are pre-diabetic. The prevalence of diabetes among the people of Gujarat has been recorded at approximately 7.1%. He noted that in a rapidly developing city like Surat, cases of diabetes are on the rise due to changes in lifestyle and dietary habits.

On the occasion of World Diabetes Day, Dr. Mukur Petrolwala, President of the Indian Medical Association (IMA) - Surat, stated that diabetes is a rapidly growing global health issue. He emphasized that the disease can be completely managed through





timely diagnosis, a proper lifestyle, and regular medical check-ups. He further noted that raising awareness about diabetes within society is the need of the hour.

Dr. Niraj Soni addressed the topic of 'Importance of Exercise - Stay Active and Be Fit in Diabetes.' He stated that regular exercise is absolutely essential for controlling diabetes. Daily walking, yoga, stretching, and overall physical activity help in long-term blood sugar management, weight control, and reducing the risk of heart disease.

Dr. Amita Tambekar provided insightful information on 'Functional Food in Diabetes.' She emphasized that a diet rich in high-fiber grains, seeds, nuts, millets, and antioxidants plays a vital role in stabilizing blood sugar levels. Furthermore, she noted that proper nutrition can simplify diabetes management by as much as 50%.

Dr. Piyush Desai shared expertise on the topic 'Obesity - Primary Target in Diabetes Management: Upstream Approach.' He stated that obesity is the leading risk factor for diabetes. Following

an 'upstream approach,' he emphasized that fundamental changes in lifestyle are necessary. By focusing on proper nutrition, regular exercise, and weight management, diabetes can be significantly prevented.

He emphasized that regular movement at the workplace, choosing healthy snacks, practicing stress management, and ensuring timely health check-ups are essential.

Dr. Parulben Vadgama, Chairperson of the Chamber's Public Health Committee, outlined the program's framework. The session was moderated by the Committee's Co-Chairman, Dr. Rajanbhai Desai. Awareness Session on Collateral-Free Loans for MSMEs



The Chamber organized an awareness session on the Business Rules Engine (BRE) for collateral-free loans up to ₹5 crore for MSMEs

The Southern Gujarat Chamber of Commerce and Industry (SGCCI) organized a special awareness session on the SBI banking product—Business Rules Engine (BRE)—on Tuesday, November 18, 2025, at 5:00 PM at the Ushakant Marfatia Hall, Sarsana, Surat. Guest speaker and SBI DGM Mr. Rajesh Kumar provided detailed information about these loans to Surat's entrepreneurs and professionals.

Chamber President Mr. Nikhil Madrasi stated that those who do not embrace change are often pushed out of the market. He noted that SBI has evolved with the times, gaining universal acceptance, and has now come to the customer's doorstep. He also provided a detailed overview of the Chamber's various activities.

Chamber Vice President Mr. Ashok Jirawala remarked that previously, textile MSME entrepreneurs had to struggle significantly to secure loans. However, loans up to Rs. 5 crore are now

available without collateral, and that too within an hour. He encouraged entrepreneurs to benefit from this facility.

Chamber Honorary Treasurer CA Mitish Modi mentioned that South Gujarat is a hub for MSMEs. During an online meeting with the RBI during COVID-19, the Chamber suggested an online loan approval system. Later, a personal representation was made to RBI Deputy Governor Mr. Swaminathan Janakiraman regarding collateral-free loans up to Rs. 5 crore for small industries. The very positive response from the Deputy Governor led to the creation of SBI's BRE software.

SBI DGM Mr. Rajesh Kumar informed entrepreneurs that a sophisticated software has been developed for business loans, requiring only Income Tax and GST user IDs and passwords. The specialty of this software is that it determines the loan limit within minutes without any human intervention.

SBI DGM Mr. Rajesh Kumar and other officials provided a detailed explanation of the BRE software, which determines loan limits quickly online, and urged MSME entrepreneurs of South Gujarat to take advantage of this facility

The Chamber of Commerce had previously made a representation to the Deputy Governor of RBI, Mr. Swaminathan Janakiraman, requesting such loan facilities for small entrepreneurs

Users can even select their preferred branch, and no collateral is required. The software sets limits based on turnover and business performance. Through this system, 900 loans totaling Rs. 433 crore have already been approved in South Gujarat. He urged entrepreneurs and suppliers to take full advantage of this.

SBI officials explained that AI-driven technology is used to set loan limits, with interest rates starting from 8.40%. Special incentives are available for women entrepreneurs. Cash credit is provided quickly, and SBI even assists MSMEs in building websites. Guidance was also given on loans for establishing captive and non-captive solar parks. Additionally, SBI has started a cluster for Surat Textiles, offering special products for loans

exceeding Rs. 5 crore.

SBI officials gave a detailed technical presentation on the BRE, explaining features like digital documentation, automated risk assessment, and real-time credit decisions. They also provided insights into on-the-spot loan approvals.

Former Chamber President Mr. Ashish Gujarati, SBI officials Mr. Harish Jain, Mr. Vikas Kumar, Ms. Rini Singh, and Mr. Desh Deepak, along with MSME entrepreneurs and professionals, attended the session. CA Vipul Shah, Chairman of the Chamber's Banking (Nationalized and Private) Committee, moderated the program. The session concluded with SBI officials answering various queries from the participating entrepreneurs and businessmen.

Online Meeting with National Center for Good Governance (NCGG)



A significant online meeting was conducted on Thursday, November 20, 2025, with Dr. Surendrakumar Bagde (IAS), Director of the National Center for Good Governance (NCGG), New Delhi. The meeting saw participation from the Gujarat Chamber of Commerce and Industry (GCC), The Southern Gujarat Chamber of Commerce and Industry (SGCCI), and several prominent associations of Gujarat.

Representing the Chamber, President Mr. Nikhil Madrasi, Vice President Mr. Ashok Jirawala, Honorary Treasurer CA Mitish Modi, and Deputy Secretary Mr. Paulik Desai participated and made detailed presentations on key issues affecting the 'Ease of Doing Business' in Gujarat.

During the online session, the government's attention was drawn to the following critical points:

1. Demand to Abolish Professional Tax: Although the amount of Professional Tax is negligible, it requires monthly compliance, creating an unnecessary administrative burden for industries, including MSMEs. Therefore, the Chamber recommended the total abolition of Professional Tax to save time and reduce the operational burden on businesses.

2. Clarity on 30% Banking under Gujarat Green Energy - Open Access Regulations: Due to varying interpretations of the clause requiring at least 30% banking of total consumption—a long-standing disputed

issue—investments made by the MSME sector in renewable energy are facing hurdles.

The Chamber requested a clear definition of this clause so that MSMEs can invest without fear, thereby fostering growth in the renewable energy sector.

3. Need to Extend Time Limits under the Gujarat Renewable Energy Policy: For renewable energy projects ranging from 1 MW to 100 MW, additional time is required for necessary approvals after receiving the Technical Feasibility Report. Previously, GUVNL had the authority to adjust these timelines, but since this power now rests with GERC, the process takes several months. This leads to project stalls and potential financial losses for industries.

Consequently, the Chamber requested a policy amendment to return the authority to extend timelines to the Energy and Petrochemicals Department or GUVNL, ensuring smoother project implementation for MSMEs and other industries.

Dr. Surendrakumar Bagde listened to all the points seriously and assured that appropriate steps would be taken after discussing them with the relevant departments. The Chamber and other associations expressed hope that suitable actions would be taken on the presented issues to strengthen the 'Ease of Doing Business' in Gujarat and provide momentum to the MSME sector.

Important Discussions on International Cargo with Air India's West Zone Cargo Head



Another major step has been taken toward progress in the city's air commerce sector. Mr. Mahesh Ganesan, Air India's West Zone Cargo Operations Head, visited Surat to conduct preliminary procedural studies and discussions for launching 'Precious International Cargo' operations from Surat International Airport. This visit is considered extremely vital for giving a new direction to international cargo handling from Surat.

The Southern Gujarat Chamber of Commerce and Industry (SGCCI) played a central role in this entire process. During the meeting held at the Chamber on November 21, 2025, Chamber President Mr. Nikhil Madrasi and the Chairman of the

Aviation/Airport Committee, Mr. Linesh Shah, were present. The Chamber is continuously striving to improve international cargo facilities and establish the city as a major cargo hub.

This visit is seen as a significant opportunity for Surat's trade, industry, and exporters. The commencement of precious cargo operations will provide direct and rapid access to global markets for Surat's diamonds, textiles, and other high-value products, thereby strengthening the city's economy.

Welcoming this initiative, the Chamber expressed its commitment to working alongside all stakeholders to firmly establish Surat on the global cargo map.

Banking Conclave 2025: Deliberations on Inclusive Growth of Cooperative Banks



The umbrella organization of cooperative banks is working on several challenges; the conclave saw the participation of urban and rural cooperative banks from across South Gujarat

The Southern Gujarat Chamber of Commerce and Industry (SGCCI), in collaboration with The South Gujarat Co-operative Banks Association Ltd. (SCOBA), organized 'Banking Conclave - 2025' on Saturday, November 22, 2025, at Avadh Utopia, Surat. Centered on the theme of 'Inclusive Growth for Cooperative Banks,' national banking leaders, policymakers, and stakeholders discussed emerging opportunities and challenges within India's cooperative banking ecosystem.

The conclave was divided into two parts. In the inaugural ceremony, Mr. Satish Marathe, Director of the Central Board of the Reserve Bank of India (RBI), discussed policy reforms, the RBI's vision for strengthening the cooperative financial system, and the critical role of cooperative banks in supporting inclusive growth in rural and semi-urban India.

In the technical session, Mr. Prabhat Chaturvedi, CEO of the National Urban Co-operative Finance and Development Corporation (NUCFDC), New Delhi—the new umbrella organization for cooperative banks—provided detailed information on NUCFDC's initiatives, future roadmap, and latest solutions aimed at enabling cooperative banks to modernize and expand their services.

Mr. Milind Kale, Vice President of NAFCUB and former Chairman of Cosmos Co-op Bank Ltd., highlighted the necessity of robust governance frameworks, digital transformation, and risk mitigation strategies to strengthen the cooperative banking sector.

Chamber President Mr. Nikhil Madrasi stated in his welcome address that the cooperative sector belongs to the poor and middle class. Even during economic crises, cooperative banks remained resilient. They have maintained such a distinct position and level of customer trust that while large banks must chase customers,


customers themselves come to cooperative banks. The government also want that co op banks should grow.

SCOBA Chairman Mr. Gautam Vyas remarked that cooperative banks have a glorious history. Technology is the bridge between the cooperative banks of yesterday and tomorrow. By embracing these changes, cooperative banks will play a vital role in the vision of a \$5 trillion economy and a 'Viksit Bharat' (Developed India). We should seize the opportunity together.

RBI Central Board Director Mr. Satish Marathe remarked that all cooperative banks in Gujarat serve as a role model for the entire country. He stated, "I even urge management institutes to study the model of Gujarat's urban cooperative banks." According to advanced data for the current year, he noted that the performance of urban cooperative banks across the nation has been at its best in the last five years. He added that while cooperative banks are doing excellent work, they now need to enhance their promotion and marketing efforts.

Presenting a picture of the country's economy, Mr. Marathe said that our economy, which was considered among the "Fragile Five" a decade ago, is in the top five today and is preparing to reach the third position. All three sectors—manufacturing, agriculture, and services—are performing very well. The number of SMEs is constantly increasing in both urban and rural areas. By giving a push to agriculture, the government has encouraged agro-processing, and the world's largest project for decentralized warehouses has started in the country.

The banking sector is at a level of strength today that it has never been before. The NPA (Non-Performing Asset) level is better than international standards. Inflation is at a historically low level. Thus, there are many growth opportunities and a favorable environment for the banking

sector, especially for cooperative banks. Every bank needs to create a vision document for growth. He said that cooperative banks need to remain well-capitalized. After COVID, the RBI had asked all banks to increase their capital.

Cooperative banks should invest in technology with the same level of concern they show for their own physical assets

Mr. Marathe stated that banking has become more complex today. He noted that the fact that enough work hasn't been done regarding technology yet is a matter of concern. While it is good that the boards of cooperative banks are concerned about having their branches in their own properties, they will become more competitive only if they also invest in technology.

Subsequently, at the start of the technical session, Mr. Prabhat Chaturvedi was introduced by Mr. Deven Choksey. Mr. Chaturvedi stated that the primary challenges for cooperative banks are technology, cybersecurity, and costs. He mentioned that the umbrella organization, NUCFDC, is taking several initiatives to address these issues.

He suggested that there should be a platform similar to PolicyBazaar for loans, and that cooperative banks should be integrated into online trading apps like Zerodha and Groww. He also noted challenges such as declining deposits. Furthermore, he discussed innovative current accounts for SMEs, products for minors, and steps to reduce UPI charges for banks. He announced that a shared Core Banking System, similar to the one in Australia, will be launched in the near future, allowing even small banks to participate.

Mr. Milind Kale stated that although the RBI has made the appointment of a Risk Officer mandatory only for banks with a loan portfolio exceeding Rs. 5,000 crore, he believes that every bank—regardless of size—should appoint

one. In this context, he cited the 2018 example of Cosmos Bank, which lost Rs. 94 crore in a massive cyber attack. He emphasized that even if intentions are noble, every financial decision carries inherent risk; therefore, cooperative banks must adopt Risk Management as an integral part of their growth strategy.

Chamber Group Chairman Mr. Nirav Mandlewala, while providing information about the entire conclave, stated that this is the first time such a conclave is being held for cooperative banks. Its purpose is to provide a well-structured business platform for the inclusive growth of cooperative banks by increasing collaboration between policymakers and regulators, and by expanding capacity through risk management. He added that in the future, cooperative banks will play a very important role in the vision of a 'Viksit Bharat' (Developed India).

Chamber Honorary Treasurer Mr. Mitishbhai Modi introduced the keynote speaker, Mr. Satish Marathe. Former Chamber President Mr. Rohit Mehta moderated the entire conclave. The vote of thanks for the inaugural ceremony was proposed by Mr. Amit Gajjar, Chairman of the Surat People's Co-op Bank, the main sponsor of the event.

The vote of thanks for the entire program was proposed by Mr. Kanjibhai Bhalala, Second Vice Chairman of SCBA. He remarked that just as India is undergoing a transformation, the banking sector is also evolving in tandem with the changing times.

On this occasion, Chamber Vice President Mr. Ashok Jirawala, Immediate Past President Mr. Vijay Mewawala, as well as Directors, office bearers, and employees of cooperative banks from across South Gujarat were present. During an engaging Q&A session, the speakers provided satisfactory answers to various questions raised by the cooperative bankers.

regarding both money and life, their investment path becomes clear, enabling them to create true wealth. He pointed out a social irony: people congratulate someone who buys a Rs. 2 crore flat on an 80% loan, yet they try to scare or discourage those who invest in an SIP (Systematic Investment Plan). He further noted that the COVID-19 pandemic has fundamentally shifted the mindset of people in India. Post-Covid, people are traveling more and are no longer willing to sacrifice the experiences they used to put off. As more people enter the formal economy, the overall economic patterns are undergoing a significant transformation.

Furthermore, he stated that expenses are bound to increase in the future. Those who are young today must ensure that by the time they grow old, their money becomes "young" (grows and stays productive). To achieve this, people must secure financial freedom

by investing at various levels starting now. Financial freedom does not lie solely in earning money; rather, it is achieved by mastering proper understanding of money, disciplined investment, risk management, and diversification.

Chamber Vice President Mr. Ashok Jirawala proposed the vote of thanks to all those present at the session. In this program, renowned transformational coach, motivational speaker, and business mentor, T.I.G.E.R. Dixit Teraiya, provided guidance as the keynote speaker. He delivered a 60-minute lively

Chamber Honorary Treasurer CA Mr. Mitish Modi, in his welcome address, remarked that while the phrase "Apna Bhi Time Aayega" (Our time will also come) is true, one must be able to recognize the opportunity when it arrives. He cited the late Dhirubhai Ambani as the best example of recognizing an opportunity. By quoting a story from Ambani's childhood, he explained that an entrepreneur can become successful only by utilizing opportunities in a timely manner.

Renowned motivational speaker Mr. Dixit Teraiya explained through various examples why entrepreneurs miss the bus of growth and fail to advance in business. He stated that major industrialists have turned their companies into "Auto-Pilot Organizations." However, 90% of entrepreneurs have not been able to achieve this. He emphasized that one can only think innovatively if they remain detached from routine day-to-day tasks. To grow as big as you desire and expand your business, you must step out of the daily operations

of your business as quickly as possible.

He further stated, "Why can't we do what successful industrialists can?" Providing several examples, he explained that there must be a specific mechanism for hiring. If a balance between obligation and commitment is not maintained, professional life is bound to deteriorate. He explained the difference between 'Revenue Work' and 'Non-Revenue Work', urging entrepreneurs to focus primarily on Revenue Work. He emphasized that 'New Thinking' is absolutely essential in business.

QCO Order on Textile Machinery Suspended by Government of India

The Quality Control Order (QCO) for textile machinery, which was originally scheduled to be implemented from September 2026, has been officially suspended by the Government of India. According to the Notification S.O. 5179(E) dated

November 13, 2025, the enforcement of this order will remain on hold until further notice from the government. Following this notification, all types of QCO orders in the textile sector have currently been suspended.

Textile Knowledge Session Organized Jointly by Chamber and MANTRA



The Southern Gujarat Chamber of Commerce and Industry (SGCCI) and the Man-Made Textiles Research Association (MANTRA) jointly organized a Textile Knowledge Session on Wednesday, November 26, 2025, at 6:00 PM at Sanhati, Sarsana, Surat. This significant session, held for Surat's textile entrepreneurs, provided detailed guidance on current textile policies, challenges, and emerging global opportunities.

Bachkaniwala, while outlining the program, stated that MANTRA is committed to taking the textile industry to new heights by focusing on technology, research, and skill development. He added that considering the changing structure of the industry and the emerging opportunities in the global market, such knowledge sessions have become extremely important.

Mr. S.P. Verma, Director of the Product Development Center at Viv Water Enviro Pvt. Ltd., provided guidance to Surat's entrepreneurs on the "Policy Framework for Indian Textiles - Current Scenario and Future Prospects." He stated that India's textile policy has undergone rapid changes in recent years, making it absolutely essential for industries to adopt technology upgradation, sustainability, waste management, and eco-friendly processes to face global competition. He emphasized that entrepreneurs must focus on green processes and environmental compliance.

Furthermore, he shared detailed information regarding the benefits of PM MITRA Parks and the related schemes of the Government of Gujarat. He stated that these parks will strengthen the textile value chain while creating vast opportunities for modern infrastructure, common facility centers, technology support, waste management, and sustainable manufacturing. The incentives and subsidy schemes provided by the Gujarat Government will make industries more competitive globally and give new momentum to Surat's textile hub.

Mr. Viral Shah, Founder and Director of the Export Import Leadership Institute, provided guidance to Surat's entrepreneurs on the topic

"Indian Textile Exports - Navigating the Current Market Scenario." He stated that vast opportunities are available for Indian industries by focusing on product diversification, branding, e-commerce, and emerging markets. Currently, 165 countries worldwide are engaged in daily export-import activities. He emphasized that the global market is looking for an alternative to China and the USA, and India is perfectly positioned to become that alternative.

He mentioned that in 1991, India's share in global exports was 0.50%, which increased to 2.0% in 2024. Efforts are now underway to take India's global export share to 8% by 2030. To achieve this, India initiated large-scale manufacturing under the 'Make in India' campaign ten years ago.

According to projections for 2025, India is expected to account for 5.5% to 5.8% of global textile exports and 3.5% to 3.8% of apparel exports. He further emphasized that Surat's textile sector is ready for global competition, and with the right market strategy and quality-based production, Surat's exports can see significant growth.

MANTRA Honorary Secretary Mr. Praful Gandhi proposed the vote of thanks to everyone present at the session. Mr. Himanshu Desai, Head of the Environment Department at MANTRA, moderated the session. The knowledge session was attended by former Chamber President Mr. Ashish Gujarati, as well as several entrepreneurs and professionals. Through the guidance of textile experts, participants gained vital information regarding textile policies, global trends, and export-import dynamics.

Awareness Session on Cervical Cancer Vaccine Organized by Chamber and Jay Sardar Vidyalaya





Chamber Vice President Mr. Ashok Jirawala, in his address, highlighted that women's health holds a special place in the health protection of society. He noted that cervical cancer is one of the most serious health challenges affecting women worldwide. But the happy news is that today, an effective and safe

preventive option—the Cervical Cancer Vaccine—is available."

Dr. Usha N. Maniya stated that cervical cancer is one of the most serious types of cancer among women, but fortunately, its timely prevention is possible. The cervical cancer vaccine available to protect against the Human Papillomavirus (HPV) is extremely effective and safe. This vaccine is recommended for girls and young women between the ages of 9 and 26 years, as protection is most effective at this age.

She further stated that taking this vaccine provides long-term protection against many high-risk strains of the Human Papillomavirus (HPV), which significantly reduces the likelihood of developing

cervical cancer in the future. Along with vaccination, she emphasized that it is also essential for women to adopt regular health checkups and a hygienic lifestyle. Dr. Usha added that if proper awareness is spread throughout society, there can be a substantial decline in cervical cancer cases.

Mr. Paresh Patel- Principal of Jay Sardar Vidyalaya delivered the occasional address. Dr. Jagdish Vagharia, Chairman of the Chamber's Industrial Workers Health Committee, outlined the program's objectives and expressed gratitude to everyone in attendance. Chamber Honorary Treasurer CA Mitish Modi was specially present at these meetings. He noted that the Sharjah Free Zone's proximity to the sea allows for rapid and easy exports. He mentioned that almost all types of businesses—excluding certain professions like CAs and doctors—are welcomed in the Sharjah Free Zone.



Furthermore, he engaged in an in-depth Q&A regarding the Double Taxation Avoidance Agreement (DTAA) between the two countries and the prospects of Ease of Doing Business. He got clarity that businesses utilizing the Sharjah Free Zone benefit significantly from these agreements, making it highly advantageous from a taxation perspective.

This two-day Business-to-Business (B2B) meet received an enthusiastic response from local industries.

The objective of this initiative was to enable Indian companies to gain strategic advantages by using the UAE as a gateway to seize global opportunities. Special emphasis was placed on how the Sharjah Airport International Free Zone

(SAIF Zone)—one of the most dynamic and investor-friendly hubs in the region—can be utilized to boost exports.

The special series of B2B meetings held in Surat significantly helped South Gujarat's industries explore investment potential, operational support, and the ease of setting up businesses in the UAE through direct interactions with SAIF Zone representatives. Participants were provided with specific guidance on how to effectively leverage the India-UAE Comprehensive Economic Partnership Agreement (CEPA). This landmark agreement provides duty-free access to approximately 97% of Indian goods and strengthens India's reach into African, European, and other international markets.

Industrial Visits Organized at Various Locations





In November 2025, the Southern Gujarat Chamber of Commerce and Industry (SGCCI) successfully organized a series of industrial visits across various locations in Surat. On November 5, 2025, a Chamber delegation visited SteamHouse India Limited located in Sachin GIDC. Detailed explanations were provided regarding their Artificial Intelligence (AI)-based steam management system and advanced pollution control technologies.

Participating members studied live presentations of advanced machinery, precision manufacturing, and 3D printing technology. This visit helped develop a deeper understanding of new frontiers in the manufacturing sector.

The third visit took place on November 19, 2025, at Make3D.in, where members received detailed



information regarding high-precision 3D printers designed at the national level, rapid prototyping, and technologies related to Industry 4.0.

The fourth and final visit of the month was organized on November 26, 2025, at Shakunt Ashram and Pragati Glass Industries. At Shakunt Ashram, Chamber members gained practical experience through a yoga session, while at Pragati Glass Industries, they received detailed information regarding the high-quality production processes involved in glass manufacturing.

Chamber President Mr. Nikhil Madrasi stated that the primary objective of this initiative was to inform members about modern technology, sustainable industrial practices, and new production models. He emphasized that such industrial visits foster innovative thinking among entrepreneurs, build confidence in adopting new technologies, and strengthen networking within the industrial sector. Awareness Session Organized by the Chamber on 'Know About Your Liver'



As part of its ongoing Health Series, The Southern Gujarat Chamber of Commerce and Industry (SGCCI) organized an awareness session titled 'Know About Your Liver' on November 9, 2025, at 10:30 AM at Samruddhi, Nanpura, Surat. Dr. Ritesh Prajapati from the renowned SIDS Multi Super Specialty Hospital, Surat, provided detailed information during the session.

Dr. Ritesh Prajapati stated that the liver is one of the most important organs in the human body, which performs vital functions such as detoxification, metabolism, the digestive process, and energy storage. Since liver-related diseases often remain asymptomatic in the early stages, regular check-ups are extremely necessary. He further mentioned that an irregular lifestyle, a diet high in oil and spices, increasing alcohol consumption, obesity, as well as

conditions like diabetes, can increase the risk of fat accumulation in the liver (fatty liver) and diseases like hepatitis."

To maintain good liver health, he advised adopting a balanced diet, engaging in regular exercise, staying away from smoking and alcohol, drinking sufficient water, and undergoing periodic Liver Function Tests (LFT).

Dr. Rakesh Gandhi, Group Chairman of the Chamber, delivered the welcome address. Dr. Jagdish Vagharia, Co-chairman of the Chamber's Public Health Committee, introduced the speaker. The entire session was moderated by Dr. Rajan Desai, a member of the Public Health Committee. During the session, the speaker also provided guidance to the Chamber members by addressing their various doubts and queries.

A New Path for Investment: Session on SIF Organized at the Chamber



An informative session on the topic “Specialized Investment Fund (SIF): A New Investment Avenue” was successfully organized by The Southern Gujarat Chamber of Commerce and Industry at Samruddhi Hall, Nanpura, Surat, on November 22nd at 5:30 PM.

In his welcome speech, Chamber Honorary Treasurer Mr. Mitish Modi stated that regular programs are being held through the Chamber to ensure everyone benefits and gains knowledge. Earlier, CAs were limited to audits; however, the current trend is such that they also play a significant role in wealth creation and wealth management.

Explaining SIF, CA Bipin Hirapara, Founder and CEO of D2A, said that the need for SIF arose as a result of successful strategies in developed countries. For SIF, an investment can be made starting from a minimum of ₹10 lakh per AMC. It allows hedging (shorting derivatives) up to 25%, which is not permitted in Mutual Funds or Portfolio Management Services (PMS). Unique features like sector rotation

have also been provided. SIF can also invest in the commodity sector.

He added that this is a completely new and advanced path for investment. It possesses the capability to provide returns even in volatile and falling markets. SEBI has currently permitted 7 categories, the first of which is equity-oriented. He also provided information regarding the tax implications for investors and AMCs. Furthermore, he answered queries troubling investors regarding expense ratios, lock-in periods, and exit loads.

On this occasion, a large number of Chamber members and investors were present. Mr. Kamlesh Gajera, Group Chairman of the Chamber, provided information about the program. Mr. Hasim Yaqubli, Co-chairman of the Chamber's Capital and Commodity Market Committee, introduced the speaker. The entire program was moderated, and the vote of thanks was delivered, by Mr. Balkrishna Vagharia, Co-chairman of the Capital and Commodity Market Committee.

'Fighting Cancer Smarter' Session Raises Cancer Awareness



Modern facilities like robotic surgery,

targeted therapy, and continuous monitoring are making cancer treatment safer, more effective, and patient-centric.

Dr. Chirag Bhansali, sharing insights on "Healing Beyond the Cure - The Power of Reconstructive Surgery," mentioned that for patients, it is not just the cure from the disease that is important after cancer treatment, but also physical, mental, and social rehabilitation. Through reconstructive surgery, physical changes resulting from cancer treatment can be corrected, restoring confidence, self-esteem, and quality of life in patients. This type of surgery helps patients return to normal life and paves the way for holistic healing along with complete cure.

Dr. Reiyaaal Goveas, providing information on "Bringing One Back to Life - The Importance of Prosthetics," stated that for patients who have lost a limb due to cancer or other serious illnesses, prosthetics are not merely physical

aids but give them the ability to live life again with self-reliance, confidence, and dignity. Due to advanced prosthetic technology, patients can perform daily tasks easily, their efficiency increases, and active participation in social life becomes possible again, providing overall rehabilitation and new hope in patients' lives.

During the session, the expert doctors also provided guidance on cancer prevention, lifestyle changes, regular health check-ups, and the importance of identifying symptoms at the earliest. Emphasis was placed especially on the need for busy entrepreneurs and professionals to remain conscious of their health.
